The Division administers teaching and research in the field of the Social Sciences, with an equal emphasis on theoretical and methodological issues and with a parallel concern for the relation of the Social Sciences to Philosophy. Its aim is to transmit and advance the empirically-grounded theories of socio-cultural phenomena, value systems and human conduct, through the sciences of Sociology, Anthropology, Psychology and the Education Sciences. It thus promotes the interdisciplinary scientific understanding of these objects of inquiry, deemed necessary also in the assessment of their philosophical treatment.

Procedures for Admission

Standard procedures

Students are admitted to the Department according to the standard procedures for entry into the Higher Education State Institutions, as these are laid down by the Ministry of Education, Research and Religious Affairs.

Enrollment by examination

Students who already hold a Bachelors degree may also be admitted to the Department through a process of written examination administered by the Department. The total number of students thus admitted may not be more than 10% of regular admission. More information is available by the Secretariat of the Department.

Specific arrangements for recognition of prior learning

Students who have previously attended another undergraduate program have the right to apply to the Undergraduate Studies Committee for the recognition of up to 9 successfully completed courses that are thematically equivalent to those offered by the Department, so that these will count towards their degree. The application should contain the list of courses to be recognized and their detailed curriculum, which has to be approved by the Department's Faculty.

General Description of Learning Objectives

Education and research objectives

The Department of Philosophy and Social Studies is one of the oldest departments of the University of Crete. Its fundamental purpose is to promote the study of Philosophy and the Social Sciences both on their own right and in their interconnections, through high-level research and teaching in both academic fields. The curriculum has been designed so as to grant its students broad knowledge in the humanities and the social sciences, as well as to acquaint them with a range of different research methodologies and equip them with strong research skills. This cause is further promoted through a lively program of research events, including seminars and colloquia

throughout the academic year as well as frequent international workshops and conferences.

The Department offers two MA Programmes: *Philosophy: Science, Values and Society,* and *Cultural Analysis and Education*. In addition, it administers a Joint Postgraduate MA Programme in *Bioethics* (in co-operation with the Departments of Biology, Medicine, Sociology of the University of Crete and the School of Law of the University of Athens). It is also one of the collaborating Departments in the

interdisciplinary MA Programme *Brain and Mind*, administered by the Department of Medicine of the University of Crete. Doctoral Degrees (Ph.D.) are also offered in all the above fields.

Regulations and Curriculum

Summary of the Curriculum. Central axes / directions of the curriculum.

Duration and teaching hours of courses:

The academic year consists of two semesters. Each semester consists of thirteen weeks of teaching and for every course three teaching hours are dedicated per week.

Description of course units

The curriculum of the Department is structured with basic and specialization courses. Basic courses are compulsory for all students of the Department and include 14 mandatory, 10 compulsory elective, and 4 foreign languages courses; the requirement of attendance of the foreign language courses does not apply to students with a certification of proficiency in the foreign languages offered. Specialization courses (12 compulsory elective and 6 free choice courses) are offered to students according to the Division they elect at the beginning of the 3rd year of their studies; free choice

courses can be selected by the students among courses offered by any of the Departments of the Crete University, thereby completing their specialization according to their particular interests and/or future study plans.

- *Students with a certification of proficiency in the foreign languages offered by the Faculty are not required to attend the corresponding courses.
- **Students of the Theory and Methodology of Social Sciences Division are required to complete 6 seminars, while students of the Philosophy Division are required to elect 3 seminars and 3 reading-type courses

Types of courses

Courses are divided in seminars lecture-type and reading-type classes, with the last one attended only by the students of the Philosophy Division. Each seminar and reading-type course can be attended by maximum 25 students. Students in lecture type courses are evaluated by written and/ or oral examination at the end of the semester, or by any alternative method of examination that the instructor will announce at the beginning of the semester. In seminars the students' performance is assessed through the oral presentation of the subject of their essay, the quality of their written essay, as well as their active participation in the class.

Courses offered to Erasmus students

A limited number of courses are offered in English but Erasmus students can choose any one of the courses offered by the Department in the semester of their visit, agreeing with the member of academic staff that runs the selected course the mode of attendance and examination. Students with the Erasmus programme are allocated the credits that correspond to the courses they have completed successfully.

Exam Periods and Exams

There are three examination periods, i.e. in January, June and September. According to the type of course attended, examinations may be written, oral, written and oral or presentation and surrender of an essay.

Rescoring

Students may take additional courses to replace successfully completed courses, the grades of which they may consider unsatisfactory. However, the replacement course needs to be a different course (i.e. a course having a different code) from the one it replaces.

Grading and Graduation Requirements

The grading system is structured as follows: Excellent (from 8.50 to 10), Very good (from 6.50 to 8.49), Good (from 5 to 6.49), Fail (from 0 to 4.99). A student graduates once s/he has successfully completed all courses that are specified by the curriculum as necessary for obtaining the degree.
